





Why we need marriage equality (same-sex marriage)

Having same-sex relationships itself is legal in Japan. However, there are significant obstacles to which only the legalization of same-sex marriage can provide solutions.

相続

Inheritance

Since same-sex partners are currently not recognized as spouses in Japan, unless explicitly stated in the partner's will, the surviving partner does not have the right to any form of inheritance including housing.

病気

Sickness

Same-sex partners may not be recognized as family at hospitals, and therefore are at risk of being excluded from life-or-death decisions or refused to be present as their partner's carer.

親権

Custody

Even when raising children as a couple, one partner will not be able to be their legal parent.

在留

Residence

If one partner is a foreign national, the necessary residency status to live a stable life together in Japan will not be granted.

Voices For Marriage Equality

Tanaka Akiyoshi-san & Kawata Yuki-san (Kagawa pref.)

We have lived together as partners for 14 years. We are open about our relationship and are accepted in the same way as a heterosexual couple would be, which is quite a rare thing in rural Japan. I bought a house for retirement, but because same-sex couples can't get married in Japan, my partner won't be able to inherit it. I desperately hope to resolve issues like that before we both grow old.



Nishikawa Asami-san & Ono Haru-san (Tokyo pref.)

We have been raising three children together for nearly 18 years. Like all "normal" families, we have been through ups and downs, but our family is not legally recognized as one. When one of us was unable to work due to battling breast cancer, we faced financial difficulty because same-sex partners cannot be treated as dependents. If one of us dies, would the other be able to take custody of the children? The worries are endless.

Lawsuits began across Japan in 2019 to have the judiciary declare that banning same-sex couples from marrying in Japan is unconstitutional. Not allowing two individuals of the same legal gender to marry infringes on the dignity of the individual and equality, both of which are protected under the constitution, and is a human rights violation. Marriage For All Japan supports the "Freedom of Marriage for All" lawsuits as well as other court cases concerning the legal protection of same-sex couples by sending out information.

Marriage For All Japan's Activities

Approaching Lawmakers

In order to increase the number of lawmakers who promote marriage equality (same-sex marriage), we hold meetings with individual lawmakers as well as informational group meetings, and also hold rallies at the Diet Member's Building (MFAJ Diet).



Events

From appearing at rainbow pride events across Japan to hosting the first ever marriage equality (same-sex marriage) themed film festival in Japan, we host a variety of events to promote marriage equality!

Approaching Companies

We started "Business for Marriage Equality", a campaign to gather businesses who promote the realization of marriage equality (same-sex marriage) in Japan. As of June 22nd, 2022, already 246 companies and organizations have joined!
